The bid shall comprise a single package containing two separate envelopes. Each envelope shall contain separately the financial proposal and the technical proposal:

- The envelopes shall be marked as “**TECHNICAL PROPOSAL**” and “**FINANCIAL PROPOSAL**” in bold and legible letters to avoid confusion.
- Initially, only the envelope marked “**TECHNICAL PROPOSAL**” shall be opened.
- The envelope marked as “**FINANCIAL PROPOSAL**” shall be retained in the custody of the procuring agency without being opened;
- The procuring agency shall evaluate the Technical Proposal without reference to the price and reject any proposal which do not confirm to the specified requirements.
- During the technical evaluation no amendments in the technical proposal shall be permitted.
- The financial proposal of bids shall be opened publicly at a time, date and venue announced and communicated to the bidders in advance.
- The financial proposal of bids found technically non-responsive shall be returned un-opened to the respective bidders; and

The bid found to be the lowest evaluated bid shall be accepted.

1. The Engineering / construction / supply / manufacturer firm shall observe the highest standard of ethics during the selection and execution of such contracts. In personals of the policy:-
 - a) Corrupt practice means the offering, giving, receiving or soliciting of anything of value to influence the action of a public official in the selection process in contract execution, and fraudulent practices means a misrepresentation of facts in order to influence a selection process of the execution of the contract to the determine of the department of Agriculture GOS, and influence collusive practices among the forms (prior to or after bid submission of propose) designed to establish crises at artificial, non competitive levels and to deprive the department of Agriculture Government of Sindh of the benefits of free and open competition.
 - b) Department of Agriculture of Government of Sindh will reject proposer for award if it determine that the firm recommended for award has engaged in corrupt or fraudulent activities in competing for the contract in question.
 - c) Department of Agriculture of Government of Sindh will declare a firm ineligible, either indefinitely or for a stated period of time to be awarded a contract if it at any time determines that the firm has engaged in corrupt or fraudulent practices in competing for, or in executing contract.
