The Project Directorate, Water Conservation and Productivity Enhancement, High Efficiency Irrigation Systems, Sindh Hyderabad, invites Sealed Tenders for the excavation of 6 water reservoirs 5 acre each with lining of 6 Water Reservoirs with Geo Membrane 0.25mm (remaining work) and lining of watercourse with PVC Geo-membrane at deh Shahpur nandni, taluka Jati, goth Begunnah district Thatta Sindh for its pilot project for sustainable agriculture through storage tanks in Thatta from the qualified firms and contractors engaged in similar activities under SPPR Rules -2010.

- 2 The Tender Document can be obtained from the Office of the Project Director, Water Conservation & Productivity Enhancement through High Efficiency Irrigation Systems, Sindh, Hyderabad, against the written request with a Pay Order / Demand Draft of Tender Cost amounting to **Rs: 2000.00**, (non refundable), in favour of Director General (AE&WM), Sindh, Hyderabad, on all Working Days upto 21-05-2010, during office hours.
- 3 The Bidding Shall be on **Single – Stage, Two - Envelope** Procedure, First Envelope should contain **Technical Proposal** only & be clearly marked as **“Technical Proposal”** the Company Profile providing all the information detailed in the Tender Documents should compulsorily be enclosed in the envelop of **“Technical Proposal”**.
- 4 Second Envelope should contain **Financial Proposal (Rates)** along with the **Bid Security @ 2%** of the **Quoted Rates** in the shape of Pay Order / Demand Draft (Refundable to Unsuccessful Bidders) and the Envelope be clearly marked as **“Financial Proposal”**.
- 5 Both Envelopes should be sealed separately and placed in the **Third Envelop**. The **Name** of the **Bidder** be clearly marked on all the Envelops.
- 6 The Sealed Tenders in Two Envelopes duly completed and addressed to Director General (AE&WM), Sindh, Hyderabad, must reach or be dropped in the Office of Project Director Water Conservation & Productivity Enhancement through High Efficiency Irrigation Systems, Sindh, Hyderabad, on the Opening Date & time mentioned in the Tender Documents.
