- Bidding documents may be purchased upon payment of a non-refundable fee at a rate given in above table, from the office of Deputy Director (Tech-II), Directorate General, Agriculture Research Sindh, Tandojam from **14-03-2009 to 30-03-2009**.
- Tenders must be delivered to the office of Deputy Director (Tech-II), Directorate General, Agriculture Research Sindh, Tandojam on or before **15-04-2009 at 11.00 A.M**. All tenders must be accompanied by;
 - The Contractor/supplier/manufacturers are required to submit a single package of their bid containing two envelops for Technical and Financial proposals separately, Each Envelops must clearly be marked a **Technical proposal** and **Financial proposal** in Bold and legible letter to avoid confusion.

4. The tender document containing Call deposit/ earnest money of 2.5% of the total value of bid in the form of pay order, in favour of Director General, Agriculture Research Sindh, Tandojam.
5. The earnest money must be attached with the tender documents.
6. Bidding is open to all interested manufacturers/ firms/ suppliers/ contractors.
7. Initially, only the envelop marked “**TECHNICAL PROPOSAL**” shall be opened.
8. The envelope marked as “**FINANCIAL PROPOSAL**” shall be retained in the custody of the procuring agency without being opened.
9. During the technical evaluation no amendments in the technical proposal shall be permitted.
10. The financial proposal of responsive bids shall be opened publicity after technical evaluation.
11. The procuring Agency may reject all or any bids subject to the relevant provisions of PPRA Rules.
12. After the evaluation and approval of the technical proposal the procuring agency shall open the financial proposals of the technically accepted bids only. The financial proposal of bids found technically non-responsive shall be returned unopened to the respective bidders; and the bid found to be the lowest evaluated bid shall be accepted.
13. Companies who want to receive the tenders through courier should obtain return courier service.
14. The bidder/supplier must quote the rate including all the taxes.
15. Tenders will be opened by the technical committee on 15-04-2009 at 12.00 Noon, in the presence of bidders or their representatives who choose to attend, at the committee room of Directorate General, Agriculture Research Sindh, Tando jam. Late tenders will not be accepted and returned unopened to bidders.
16. There will be no price negotiations with the lowest evaluated responsive bidders. Suppliers are therefore requested to submit their lowest and best prices with their tenders.
